#### **Purpose**

The purpose of this report is to provide County Council information and recommendations pertaining to tender results for a culvert rehabilitation project to be undertaken as part of the 2019 Rehabilitation Program.

## **Background**

The 2019 Structure Rehabilitation program includes the complete replacement of the concrete box culvert on County Road 27 at the Billings Drain located in the Town of Kingsville.

The works are intended to occur during the summer of 2019 with anticipated start date by the end of July.
