# 11.1 Ontario Cannabis Legislation Implementation Fund - County Allocation Redistribution

Report Number 2019-0403-ADM-R04-RM, dated April 3, 2019 from Robert Maisonville, Chief Administrative Officer.

Mr. Maisonville presented his report on the Ontario Cannabis Legalization Implementation Fund and the proposed reallocation of funds received by the County.

He explained the purpose of the funds was to support municipalities with additional expenses related to the legalization of cannabis, including enforcement and development of policies, and that it was acknowledged that currently the local municipalities were going to experience more incremental costs than the County.

He noted that the Appendix to the report highlighted the reallocation of funding received and further reported that costs related to cannabis legalization would be reported to Council throughout the year and to the province as required.

# 11.2 Small Scale on Farm Business Optional Subclasses

Report Number 2019-0403-FIN-R007-SZ, dated April 3, 2019 from Sandra Zwiers, Director of Financial Services/Treasurer.

Ms. Zwiers presented her report on Small Scale on Farm Business Optional Subclass (tax reductions for eligible properties). She explained that MPAC had returned 14 properties across the County which meet the criteria to be eligible for this optional new subclass. She further advised that a meeting was held at the end of March, 2019 with the local treasurers and tax collectors, in conjunction with discussions with a property tax consultant, to discuss concerns

and comments relating to the adoption of this optional subclass and the impact it would have on the identified 14 properties and similar properties which were not identified as being eligible.

She advised concerns of the group focused on:

- Fairness of not including similar type businesses which were not identified by MPAC;
- Creating sub-classes deemed unnecessary;
- Changing taxation policy after tax ratios and tax rates had been established for the year and the cost to administer the change.

She further noted that a province-wide review determined that only three municipalities in the province had adopted the new subclass at that time and that the majority where waiting to make that decision for the 2020 taxation year.

She did advise that, per the legislation, all 14 of the eligible properties would receive a reduction in their education taxes, regardless of tax policy decisions made on the local/County portion.
