Purpose

The purpose of this report is to provide County Council information and recommendations pertaining to the tender results for the construction of paved shoulders along County Road 50 to be undertaken as part of the 2019 CWATS Program.

Background

Included in the approved 2019 CWATS Program, are 2 projects along County Road 50, in the Towns of Kingsville and Essex. The projects were approved by the CWATS Committee with the Towns agreeing to fund their share (60%) of the project costs. This project will provide a total of 4.9 km of active transportation facilities consisting of paved shoulders on both sides of the road. A tender for the construction of the active transportation pathway along County Road 50 was issued for the location as shown on the attached map.

Discussion

The following is a summary of the tenders received. All amounts do not include HST.

The tenders were reviewed for compliance with the specifications and mathematical accuracy.

Financial Implications

Funds to support the County share of the projects are included in the annual CWATS program. The project costs are shared between the County and the respective Town(s) as established in the CWATS cost share formula of 60% to the Town and 40% to the County. The Towns were provided an opportunity to review and approve the funds acknowledged in the tender results.
