This Agreement, made in Triplicate, this 4<sup>th</sup> day of September, 2019.

The **Corporation of the County of Essex**

(Hereinafter Called **Essex County**)

**Whereas** By-law #35-2017 established the remuneration agreement to reflect the appointment of the Windsor Fire & Rescue Chief as the Essex County Fire Coordinator; the appointment of the Windsor Fire & Rescue Deputy Chief as an Essex County Alternate Fire Coordinator; and the Tecumseh Fire Chief as an Essex County Alternate Fire Coordinator, effective May 1<sup>st</sup>, 2017;

As Whereas By-law #42-2018 amended the remuneration agreement to reflect that one Essex County Alternate Fire Coordinator position was vacant, due to the resignation of the Windsor Fire & Rescue Deputy Chief;

And Whereas the retirement of the Tecumseh Fire Chief created a vacancy for the second Essex County Alternate Fire Coordinator position, effective July 1, 2019;

And Whereas the Ontario Fire Marshal is recommending the appointment of Windsor Fire & Rescue Deputy Chief James Waffle and Lakeshore Fire Chief Don Williamson to fill the Essex County Alternate Fire Coordinator positions;

**Now Therefore** in consideration of the premises, the Parties hereto agree as follows:

1. **That** Essex County shall pay an honorarium to the Alternate Fire Coordinators, the sum of **Two Thousand Five Hundred Dollars** (\$2,500.00) per annum for services rendered to Essex County by James Waffle and Don Williamson, pro-rated for 2019 for a 6 month period.
2. All other terms and conditions of the remuneration agreement authorized by By-law Number 35-2017 shall remain in effect.
