

### The Corporation of the County of Essex By-Law Number 2020-35

### A By-law to Authorize the Purchase of Certain Lands for the Widening of a Portion of County Road 19 to accommodate a Widening of a Portion of County Road 19 from County Road 22 Southerly to South of Jamsyl Drive.

**Whereas** the Corporation of the County of Essex has authorized, pursuant to By-law No. 2020-34, the acquisition of certain lands to the east and west of County Road 19 between County Road 22 southerly to south of Jamsyl Drive, in the Town of Tecumseh;

**And whereas** the Corporation of the County of Essex desires to purchase certain lands owned by third parties to allow for the widening and reconstruction of County Road 19 between County Road 22 southerly to south of Jamsyl Drive, in the Town of Tecumseh, on terms and conditions to be negotiated with the third party owners;

**And whereas** the Corporation of the County of Essex deems it expedient to complete the purchase of the said lands on terms and conditions to be negotiated.

# Now therefore the Council of the Corporation of the County of Essex hereby enacts as follows:

1. That the administration of the Corporation of the County of Essex are hereby authorized to take any and all steps necessary to enter into agreements to purchase and to complete the purchases of certain parts of lands now designated as Parts 1 through 32, inclusive, on Reference Plan 12R-28329. A copy of the said Reference Plan 12R-28329 is attached hereto as **Schedule "A"**.

2. That the administration of the Corporation of the County of Essex are hereby authorized to take any and all steps necessary to enter into agreements to purchase and to complete the purchases of certain parts of lands now designated as Parts 1 through 7, inclusive, on Reference Plan 12R-28331. A copy of the said Reference Plan 12R-28331 is attached hereto as **Schedule "B"**.

3. The Warden and the Clerk of the Corporation be and the same are hereby authorized to execute and affix the Corporation's seal to any and all documents that may be necessary to complete the purchase transactions set out above and to otherwise give effect to the terms of this By-law.

This By-law shall take effect on the final passing thereof.
