7. County Warden's Welcome and Remarks

Warden McNamara welcomed the members of County Council, Administration and members of the public and delivered the following greetings:

Welcome all to the meeting. Congratulations to Mayor Hilda MacDonald on her election to the AMO Board of Directors Small Urban Caucus over the next 2 years.

I would like to begin by expressing my condolences to the family and friends of those who have died from COVID-19. We lost a Windsor and Essex County resident last week and we lost one more yesterday, bringing to 73 the number of local people killed by this terrible virus.

It serves as a grim reminder that COVID-19 is still stalking us, still waiting to strike and to spread when we let down our guard. It's easy to forget sometimes now that the economy has reopened and regular routines have resumed, but COVID-19 is not gone. There were 12 new cases reported Tuesday morning and we all need to remain vigilant and continue following health guidelines.

I know Windsor and Essex County residents are suffering from COVID-19 fatigue because I'm suffering from it as well. It hasn't been easy and it likely won't get easier in the short-term. But we must not undo all the good we've done by growing complacent now, especially with our children going back to school. Keep on doing what you've been doing. Steel yourself and stay the course. We'll get through this together.

The employees of the County of Essex have been rock-solid during this crisis, delivering essential services, completing vital infrastructure projects and backing up the frontline workers at Sun Parlor Home and Essex-Windsor EMS, who have been working around the clock, seven days a week, to keep this community safe and this virus at bay.

Members of the Vulnerable Patient Navigator Team at Windsor-Essex EMS helped test thousands of nursing home residents at the height of the pandemic. They are receiving certificates of recognition from Windsor-Tecumseh NDP MPP Percy Hatfield.

Congratulations to David Cakebread, Grace Morneau, Holly Beck, Jen Miner, Justin Lammers, Kim Schroeder, Krista Hillier, Mark Evon, Michella Mollicone, Nick Jovanovic, Prentice Scott, Shawn Arrand, Slav Pulcer, Stacey Shepley and Ziad Fatallah. You have represented the County of Essex with honour and distinction. I thank you, and all County of Essex employees, for the dedication, diligence and unwavering professionalism shown during this pandemic.

I'm pleased to announce that work has begun with the Essex Region Conservation Authority and our municipal partners on a Regional Energy Plan to address the pressing issue of climate change. This plan will identify consumption patterns and opportunities, develop green energy strategies and create economic development opportunities.

15. Notice of Motion

15.1 Reserve Lands Limiting Access on County Road 42, as Related to Essex County By-law 50-2019

Joe Bachetti made a Notice of Motion pertaining to Reserve Lands Limiting Access on County Road 42, as related to Essex County Bylaw 50-2019.

Joe Bachetti made the following statement:

This Notice of Motion pertains to County By-law 50-2019, which was adopted by County Council on November 20, 2019. The By-law authorizes a 0.3-metre (one foot) reserve limiting additional access onto County Road 42 from the City of Windsor municipal boundary to Pike Creek in the Town of Lakeshore.

Included in the area affected by this By-law is that portion of County Road 42 that extends through the Tecumseh Hamlet in the Town of Tecumseh. Tecumseh Hamlet is an approved urban Settlement Area in the County's Official Plan and the Town's Official Plan.

The imposition of a 0.3-metre (one foot) reserve in this designated urban Settlement Area is an unwarranted form of corridor control and is not consistent with the County's Council-approved policy documents. The existing County Permitting process is sufficient to adequately regulate corridor control in urban settlement areas.

Currently, through the County's expropriation process, the Town of Tecumseh has commenced a Hearing of Necessity for affected Town lands primarily on the matter of the 0.3-metre (one foot) reserve. The intent of this request is to avoid the cost and time for the Town and the County to resolve this matter through legal proceedings.

The request of the Town of Tecumseh is for County Council to direct that County Administration prepare an amendment to the By-law that has the effect of removing the one-foot reserve for that portion of County Road 42 that is within the Tecumseh Hamlet.

Technical Background:

The Lauzon Parkway Improvements, Environmental Study Report (ESR) was completed on January 20, 2014 by the Ministry of Transportation, City of Windsor and the County of Essex. The study's main corridors included the Lauzon Parkway (and extension to Highway No.3), County Road 42 (Walker Road to County Road 25 (Puce Road)) and the future East-West Arterial in the City of Windsor.

The ESR went into great detail on the Recommended Preliminary Design Plates depicting alignments and required property, the appropriate locations for a 0.3-metre (one-foot) reserve, along with various road cross-sections of the corridors. On County Road 42 alone, the ESR detailed 14 different road cross-sections to suit the varying site constraints (three in the City of Windsor, four in the Town of Tecumseh and seven in the Town of Lakeshore).

The ESR had recognized the preferred plan for County Road 42 in the Town of Tecumseh to have a context sensitive design as it traversed through the Tecumseh Hamlet, a designated urban Settlement Area in the County's Official Plan (OP) and Tecumseh's OP. There are a number of sections and appendices within the ESR that underscore a deliberate recognition of the importance for unique street design elements that change along the entire County Road 42 corridor in Windsor, Tecumseh and Lakeshore. These unique design elements are in response to a changing context along the corridor and were given careful consideration after thoughtful input from a range of stakeholders throughout the development of the ESR, including Provincial, County and Municipal staff (from

Tecumseh, Windsor and Lakeshore), various agencies and the public.

More specifically the following excerpt from the ESR and County Official Plan are of relevance to this issue:

- 1. Page B.4-8 of the ESR (under the subheading "County of Essex: County Road 42 Corridor Protection Strategy") reads: "The County of Essex, through reviews of the Official Plan, should ensure there is sufficient policy direction to protect the longterm effectiveness of the Regional Road System". Page 28 of the County Official Plan, adopted February 19, 2014 (under the subheading "Section 2.8.1 Roads") reads: "When considering matters of land use planning, the County shall: e) strive to minimize conflict between local and non-local traffic by protecting the County Road system depicted on Schedule "D1" ... New development proposing access onto County Roads outside of "Settlement Areas" shall be managed according to the County's access policies" (bolding added for emphasis). The segment of County Road 42 of concern to the Town is within the Tecumseh Hamlet, a designated Settlement Area in the County Official Plan;
- 2. Page B.6-44 of the ESR (under the subheading "Access") reads: "A 0.3 m reserve is proposed along County Road 42 from County Road 19 (Manning Road) to County Road 25 (E. Puce Road)." Accordingly, the ESR does not provide for a 0.3-metre reserve on County Road 42 within the designated Settlement Area of Tecumseh Hamlet;
- 3. Starting on Page B.6-13 of the ESR (under the subheading "City/County Boundary to County Road 19 (Manning Road)") there are four Exhibits depicting the Typical Cross-Section of County Road 42 within the Town of Tecumseh (Exhibits B.6-9 to B.6-12). A 0.3 metre reserve is not depicted on those cross-sections, which is consistent with the description on Page B.6-44;
- 4. Starting on Page B.6-17 of the ESR (under the subheading "County Road 19 (Manning Road) to County Road 25 (E. Puce Road)") there are seven Exhibits depicting the Typical Cross-Section of County Road 42 within the Town of Lakeshore (Exhibits B.6-13 to B.6-19). A 0.3 m reserve has been depicted on those cross-sections and is consistent with the description on Page B.6-44;

5. The ESR clearly establishes the portions of County Road 42 that are to be subject to a 0.3-metre (one foot) reserve, and excludes the section of County Road within the Tecumseh Hamlet.

The County of Essex commenced the Detailed Design of County Road 42 from the City of Windsor municipal boundary to Pike Creek in the Town of Lakeshore in early 2018. The work generally includes widening the roadway to a five-lane cross-section with bike lanes, sidewalks and multi-use trails, roundabouts at County Road 43 and County Road 19, street lighting and utility improvements. The project also includes a section of the proposed County Road 43 diversion from Shields Avenue to south of County Road 42.

Notice of Motion:

Whereas By-law 50-2019 is a By-law that seeks to create a 0.3-metre (one foot) reserve limiting additional access onto County Road 42 from City of Windsor municipal limit, through the Town of Tecumseh to Pike Creek in the Town of Lakeshore;

And Whereas this By-law includes that portion of County Road 42 that extends through the Tecumseh Hamlet in the Town of Tecumseh;

And Whereas Council Report #2019-1120-IS-R030-JM recommended the adoption of the By-Law 50-2019, and stated: "As recommended in the EA, a 0.3 metre (one (1) foot) reserve limiting additional access onto CR 42 has been identified on the property plans.";

And Whereas this is contrary to the County approved Lauzon Parkway Improvements, Environmental Study Report (ESR), and the County Official Plan, as outlined in the Technical Background to this motion.;

Now Therefore Be It Resolved That direction be given to County Administration to prepare an amendment to By-Law 50-2019 for County Council's consideration, with said amendment to remove the 0.3 metre (one-foot) reserve within the Tecumseh Hamlet Settlement Area, more specifically described as follows:

- Parts 2, 4, 6, 8, 9, 10, 12, 13, 15, 16, 17, 32, 33, 36, 37, 40, 41, 44 and 45 of 12R-27997;
- Parts 2, 4, 6, 9, 11, 13, 15, 17, 19, 21, 23, 25, 27, 29, 31, 33, 35, 37, 39, 41, 44, 46, 49, 51, 53, 55, 58, 61, 65, 67 and 69 of 12R-27999;
