### 7. County Warden's Welcome and Remarks

Warden McNamara welcomed the members of County Council, Administration and members of the public and delivered the following greeting:

A week from now, at the eleventh hour on the eleventh day of the eleventh month, we will salute our fallen soldiers and all those who fought for freedom, who sacrificed so much for the peace and prosperity we take for granted today.

Nearly 61,000 Canadians were killed during the First World War and another 172,000 were wounded. More than 45,000 Canadians were killed in the Second World War and another 55,000 were wounded. More recently, 158 Canadian soldiers were killed and 1,800 others wounded in Afghanistan.

Windsor and Essex County residents turn out by the thousands at Cenotaphs across the region each Remembrance Day to honour our military heroes, but we must avoid those large public gatherings this year.

We owe our fallen heroes a debt we can never repay, but we can honour their legacy best by continuing to make smart, selfless decisions to keep our community safe and slow the spread of COVID-19.

Please, participate virtually this year and watch the proceedings on your smartphone or computer screen. You can pay tribute to our Veterans in other ways by making sure you are wearing your Poppy or supporting Royal Canadian Legion Halls, which, like many other organizations, are struggling to survive in the midst of this pandemic.

We emerged victorious in both World Wars because of the individual actions of so many Canadians united in common cause, from soldiers overseas to farmers tending crops to mothers working in munitions factories. We mobilized the entire country and everyone made sacrifices, at home and abroad, in order to defeat the enemy.

It is this same indomitable spirit that will see us safely through the COVID-19 crisis.

I would like to highlight some fantastic news the County of Essex received last week that is included in tonight's agenda package.

Southwestern Integrated Fibre Technology announced it had awarded \$19 million in contracts that will bring fast and reliable Internet service to more than 5,100 homes and businesses in Essex County by the end of 2022. These newly awarded projects will service more than 260 kms of roadway in Essex, Kingsville, Leamington and Lakeshore.

These investments in crucial connectivity recognize the essential role that fast and reliable Internet access plays in attracting investment, encouraging innovation and creating opportunities for education and economic prosperity. If this pandemic has taught us anything, it's that high-speed internet access is not a luxury, it is a necessity.

The provincial government announced today it was investing nearly \$1 billion over six years to expand broadband and cellular access across the province. This is a fantastic news and we will work with the province to ensure that funding flows to connect under-serviced areas in Essex County.

### 11.1 Essex County Library Board

Essex County Library Board Meeting Minutes, dated September 23, 2020, Nelson Santos, Chair.

Nelson Santos updated County Council on the Essex County Library. He noted that the Amherstburg branch would soon open, making at least one branch in each municipality now open and accessible to all patrons.

Mr. Santos indicated that home delivery and 24/7 online digital delivery continued to remain available to the public.

## 11.2 2020 Essex-Windsor Emergency Medical Service - Response Information Report

Report number 2020-1104-EMS -R004-BK 2020 Essex Windsor Emergency Medical Service Response Information Report, dated November 4, 2020 from Bruce Krauter, Chief, Essex-Windsor EMS.

Chief Bruce Krauter discussed the Response Information Report for Essex-Windsor EMS. He indicated that the data was collected through both the Central Ambulance Communication Center (CACC) and the Electronic Patient Care Records (ePCR), which provided for a more in-depth report.

Chief Krauter noted that the CACC data did not include patient contact or transport to hospital, and therefore varied from the ePCR data. He provided updates on the numbers for response time averages for each local municipality. He noted a decrease in response times and projected a similar pattern for the whole of 2020 for all but one municipality (Essex).

Chief Krauter indicated that response times were relatively consistent across the region. He noted that an overall decrease was attributed to the Vulnerable Patient Navigator program, the Emergency Room Diversion program and the Low Acuity Transport initiative, which all allowed for resources to be more available for "life and limb" (code 4) responses.

Chief Krauter noted the postponement of the EWEMS Master Plan Realignment Project due to the pandemic. He stated that the planned realignment would instead take place in 2021. It was anticipated that the realignment would further lower response times by improving resource utilization.

Chief Krauter advised that 'Treat and Release' and 'Treat and Refer' projects were being explored, with the hope of replicating the VPN model and ensuring additional resource availability. Essex-Windsor EMS would continue to collaborate and innovate with community partners.

Aldo DiCarlo thanked Chief Krauter for his report and noted that page 63 - Town of Amherstburg statistics are identical to the City of Windsor statistics. Chief Krauter indicated he would review that section for errors and advise.

Richard Meloche thanked Chief Krauter for the detailed information and noted that staff in Essex would be working hard to explore alternative measures for non-emergent transport.

Nelson Santos thanked Chief Krauter and noted the mental health piece as a focus for future care. He requested shared data with community partners to help identify areas to address the growing mental health concerns.

Chief Krauter noted that an alternate destination protocol was implemented during the pandemic to transport mental health

patients to Hotel Dieu Grace (the governing facility for the Canadian Mental Health Association (CMHA)). He further noted that EWEMS piloted a low acuity and non-injured patient referral, but with little success. He advised that the Ontario Health Team (previously the ESC LHIN) were meeting weekly to discuss offload delays and mental health concerns. WRH Met campus was also adding 10 beds, and was set to focus psychiatric health at Ouellette campus. Chief Krauter indicated that budget requests would include funds for expanding mental health patient focus.

Warden McNamara extended thanks to Essex-Windsor EMS on behalf of the County and Administration, for their continued efforts to focus on both physical and mental health patient care. He noted the pressures of the opioid crisis and the need for continued monitoring.

## 11.3 County Road 19 Notice of Expropriation

Jane Mustac summarized the report on County Road 19 and the formal expropriation process pursuant to By-law 2020-04.

Ms. Mustac updated Council on the steps that were taken to prepare for the expropriation of lands 1-32 and 1-7 and requested authorization to register the expropriation and proceed with negotiations.

### 11.4 2021 Rehabilitation Program - Early Release

Report number 2020-1104-IS-R031-JM 2021 Rehabilitation Program - Early Release, dated November 4, 2020 from Jane Mustac, Director of Infrastructure Services/County Engineer

Jane Mustac highlighted current projects for the 2021 Rehabilitation Program - Early Release.

Ms. Mustac summarized the 2020 projects, noting that the early release program authorized in December 2019 supported a shovel-ready season in early March, 2020, which assisted with moving projects along at a steady pace. Projects were successfully completed, even through the pandemic.

Ms. Mustac shared pictures of 2020 projects that were taken with a drone. Ms. Mustac noted construction challenges with asphalt repairs, but indicated that traffic challenges were slightly reduced due to lack of road traffic during the pandemic.

Ms. Mustac advised that a review and comparison of all roads took place as part of the 2021 Rehabilitation planning, noting that some roads, by their nature were more difficult to predict and may require repair sooner than expected. As such, the program has built-in contingencies for these situations.

Ms. Mustac requested the early release of the estimated value for Road Rehabilitation and approval of the paved shoulder program. She indicated that additional road needs were identified and noted in the County Asset Management Plan for 2021, as well as included in budget consideration. She noted that a formal budget document would be presented to County Council during budget season.
