

The Corporation of the County of Essex By-Law Number 2020-49

A By-law to Authorize the Execution of an Agreement for the Provision of 9-1-1 Primary Public Safety Answering Point (P-PSAP) Services Agreement Between The Corporation of the County of Essex and Her Majesty the Queen in Right of The Province of Ontario as Represented by the Ministry of the Solicitor General on Behalf of the Ontario Provincial Police (O.P.P.)

Whereas the municipalities of the County of Essex deemed it necessary and proper to provide a 9-1-1 Emergency Telephone Reporting System to the residents of Essex County by authorizing the execution of Bylaw 3141 on October 19, 1994;

And Whereas By-law 3141 authorized the execution of a Joint Powers Agreement as a part of the Essex County 9-1-1 Emergency Telephone Reporting System;

And Whereas By-law 3141 permitted the Joint Powers Agreement through Article I to authorize the Corporation of the County of Essex to execute on behalf of the municipalities of Essex County and the Police Services Boards, the Public Emergency Reporting Services (PERS) Agreement with Bell Canada;

And Whereas the Corporation of the County of Essex has entered into an Agreement with Bell Canada for that purpose;

And Whereas pursuant to this Agreement, it is the obligation of the Corporation of the County of Essex to provide and operate 9-1-1 Primary Public Safety Answering Point (P-PSAP) for the 9-1-1 Serving Area;

And Whereas the Corporation of the County of Essex may contract with a third party for the management and operation of the P-PSAP;

And Whereas the Corporation of the County of Essex wishes to contract with the Ontario Provincial Police (O.P.P.) for the management and operation of the P-PSAP;

Now therefore the Council of the Corporation of the County of Essex hereby enacts as follows:

- 1. That the Warden and Clerk be and they are hereby authorized to execute the 9-1-1 Primary Public Safety Answering Point (P-PSAP) Services Agreement with O.P.P., attached hereto, and affix the Corporate Seal thereto.
- 2. That this By-law shall come into force and take effect on the day of passing.

This By-law shall come into force and take effect after the final passing.
