Purpose

The purpose of this report is to inform County Council of the revised Ontario Community Infrastructure Fund (OCIF) 2022 allocation to the County of Essex of \$2,082,590, and to recommend additional road rehabilitation projects.

Background

The Ontario Ministry of Infrastructure provides financial support to small and medium sized municipalities, to renew and rehabilitate core infrastructure, through the OCIF program. A formula-based funding model is used by the province to distribute the funding, and considers several factors including: value of the core infrastructure, property assessment and household income. Following the 2022 budget presentation to County Council, the Ministry informed the County of Essex of the 2022 formula allocation.

Typically, OCIF funding is used to renew, rehabilitate or replace the core infrastructure of roadways, and the full amount is spent in the year it is received.

Discussion

Annually, the Infrastructure Services Department evaluates pavement based on surface condition, ride quality, friction, rutting, base condition and drainage. The department uses a basic three-tier approach of: reconstruction, rehabilitation and preventative maintenance. The worst highways are reconstructed, poor highways are rehabilitated and the life of good pavement is extended through preventative maintenance.

Rehabilitation projects are planned and prioritized into our State of Good Repair Program, which is a rolling five-year plan. The plan considers condition, remaining service life, traffic volumes, truck volumes, cost/benefit, ride quality, maintenance savings, and condition of bridge/culverts in a corridor.

The annual rehabilitation program, as well as the 5 Year State of Good Repair Program, support the principles and objectives established in the Corporation's Asset Management Plan. Our rehabilitation program also separates longer road segments into affordable sections which allow distribution throughout the County.

Administration is recommending that the additional OCIF funding provides an opportunity to bring forward future segments into the current construction year.

The following table identifies the proposed sections of roadway recommended to be advanced into the 2022 construction program.

Financial Implications

The OCIF announcement for 2022 provides an additional \$2,082,590 in funding for core infrastructure. The program presented in Table 1 identifies recommended project opportunities that would fully expend the Ontario Community Infrastructure Funding allocation for 2022.

Recommendation

That Essex County Council approve the expenditure of an additional \$2,082,590 in the 2022 Road Rehabilitation Program, and; that the additional expenditure be funded by the Ontario Community Infrastructure Fund 2022 allocation of \$2,082,590 as outlined in report number 2022-0119-ISD-R01-AB.
