Happy New Year Everyone:

I hope you all had time to relax and enjoy some holidays. Looks like we're back to where we were last year at this time – working from home again.

In November or December of 2021, your Council's received a delegation from Michelle Bishop, General Manager of the EWSWA, regarding the proposed Food and Organics Waste Management Project. The delegation was prompted by the following resolution of County Council in October 2021:

"THAT Essex County Council consider a Regional approach to the Food and Organics Waste Management Project as it relates to participation from municipalities and report its decision back to the Essex-Windsor Solid Waste Authority no later than December 31, 2021."

I was wondering if I could get an update from each municipality on whether your Council has made any decisions on being a participant in a regional organics initiative or if they have not made any decision, if there are any scheduled future meetings to discuss this. To date, I have only received correspondence with a resolution from the Municipality of Lakeshore.

I had advised EWSWA Administration that County Council was not going to have a response by the proposed December 31, 2021 deadline, but I'm seeking information on whether there will be anything to report back to County Council by their January 19<sup>th</sup> meeting (Agenda going out January 14<sup>th</sup>).

If there are resolutions which your Council adopted, can you please send me a copy and if your Council has not passed a resolution, please advise if there are any plans for them to discuss this further.
