9.1. County of Essex Official Plan Review - 2023 Update

Rebecca Belanger, Manager, Planning Services and Larry Silani, Official Plan - Planning Advisor, to make a presentation regarding the County of Essex Official Plan Review - 2023 Update. (See Agenda Item - Reports and Questions Number 12.1)

Rebecca Belanger updated Council on the report that was brought forward in February of 2022 regarding the comprehensive work plan for the County of Essex Official Plan Update.

Ms. Belanger explained that the review would be completed in three phases. Phase 1 was complete and included the Phase 1 Background Report prepared by Miller Silani Inc and the Growth Analysis Report prepared by Watson and Associates Economists Ltd. Phase 2 would include the policy options report and additional technical studies; followed by Phase 3 which would include steps to draft and adopt the new County Official Plan.

Ms. Belanger provided an overview of the actions taken throughout Phase 1 including workshops, meetings and consultations with upper and local tier Councils, local tier Senior Planning staff and various stakeholders to provide the necessary input to prepared the reports.

Larry Silani provided council with information regarding the key takeaways that were obtained during Phase 1; for use in Phase 2 and 3. Mr. Silani commented that the County of Essex is unique to other communities in the province by being a peninsula surrounded on three sides by the United States. The report provided considered this unique geography to arrive at a list of strengths and weaknesses of the County. Mr. Silani pointed out that the report

projected 20-30 years into the future and was focused on land use policies to protect the rich natural resources and strengths of the County. Mr. Silani outlined the challenges facing the County of Essex including housing affordability and servicing constraints. Larry explained the goal was to continue to grow by streamlining processes while protecting the agricultural land space and ensuring the building and design of amenities serve residents and the environment.

Ms. Belanger outlined the next steps in the work program to complete the Official Plan by the end of 2023.

Discussions included the impacts of Bill 23, More Homes Built Faster Act, 2022, to the plan review process and the efforts planned to streamlining the permitting and approval processes at the two levels of government.

12.3.2023 Budget Update and Final Approval

Report number 2023-0118-FIN-R01-SZ, 2023 Budget Update and Final Approval, dated January 18, 2023, from Sandra Zwiers, Director, Financial Services/Treasurer

Sandra Zwiers recapped the adjustments requested at the budget deliberation meeting of December 7, 2022 and the resulting impact to the 2023 budget value.

Ms. Zwiers updated Council on information received since the December 7, 2022 budget deliberation meeting, specifically information pertaining to Essex County Library pay equity settlement. Ms. Zwiers explained that drawing the required funds

from both Library and County accrued payroll reserve funds and rate stabilization reserves would satisfy the expense and have no impact to the proposed 2023 budget.

Information received on December 9, 2022 indicated that the Ontario Community Infrastructure Fund (OCIF) contribution to the County would be reduced by the maximum allowable decrease of 15 percent. Ms. Zwiers explained that administration was aware of the threshold range and considerations were made in the 2023 budget to, if required, draw the shortfall from the Infrastructure Capital reserve as a one-time expense.
