Purpose

The purpose of this report is to provide County Council with information and recommendations pertaining to tender results for road rehabilitation work to be undertaken as part of the 2023 Rehabilitation Program.

Background

Upon approval of the 2023 Rehabilitation Program, tenders were published for the annual Hot Mix Overlay and Mill and Pave component.

The scope of this work includes both mill and pave operations, which involves the removal of the top layer of deteriorated pavement and placement with a new surface layer of hot mix asphalt, and hot mix overlay operations, which involves the direct overlay of a new surface layer of hot mix asphalt on the existing pavement structure.

Integral, planned projects under the County Wide Active Transportation (CWATS) budget, such as paved shoulders, were included in the subject contract. Under this approach road rehabilitation and shoulder construction will occur simultaneously which, in turn, will yield the maximum benefit in both costing and pavement rideability. CWATS paved shoulder opportunities that fell in line with the County's rehabilitation program for 2023 include County Road 3 and County Road 31.

The full Hot Mix Overlay and Mill and Pave program, with integrated paved shoulders, is presented in Table 1.

In support of regional cooperation, these contract documents include provisional items for the pavement rehabilitation of Wright Road and Arthur Street South in the Town of Essex. Subject to approval by Essex Town Council, this provisional work, in the amount of \$235,090 (plus applicable taxes), will be completed as part of these contract works and paid for in full by the Town of Essex.

Discussion

A summary of the tenders received is presented in Table 2. All amounts do not include HST.

The tenders were reviewed for compliance and mathematical accuracy by the County's Procurement Department. It is the opinion of this Administration that these tender submissions represent an appropriate understanding of the scope of work as tendered, and reasonably reflect industry costs at this time. Mill-Am Corporation is the low bidder for this tender.

Financial Implications

The tender results are aligned with the estimate prepared by this Administration however, as can be seen in Table 3, they fall slightly above the proposed budget for the Hot Mix Overlay and Mill and Pave Contract. Considering the road component of the 2023 Rehabilitation Program as a whole, the collective costs to complete all of the planned asphalt paving work still hold a favourable variance of approximately \$350,000.

All amounts in Table 3 include Net HST.

Incorporated in this Hot Mix Overlay and Mill and Pave tender is the CWATS Paved Shoulder work. As discussed earlier within this report, aligning the active transportation facilities identified in the CWATS Master Plan with the Road Rehabilitation Program, where possible, has proven to be advantageous to both the County of Essex and the lower tier municipalities. A financial breakdown of the costs associated with the CWATS paved shoulder program is presented in Table 4. All amounts shown include Net HST.
