For the Rental and Use of Vacant Land

WHEREAS:

- A. The Authority, The County and The Tenant are currently parties to a lease agreement dated May 3, 2016 whereby the Tenant is leasing certain vacant farm lands
- B. The current agreement commenced on November 1, 2016 and expired on October 31, 2021 unless an extension is mutually agreed upon by the parties
- C. The current agreement allows for three optional one-year extensions if mutually agreed upon by all parties
- D. In November 2020, approximately one year in advance of the termination of the initial five-year term, The Tenant expressed to The Authority the desire to exercise the first of three one-year extensions
- E. On December 1, 2020 the Authority Board resolved to exercise a one-year extension for the period November 1, 2021 October 31, 2022
- F. On December 16, 2020 County Council resolved to exercise a one-year extension for the period November 1, 2021 October 31, 2022
- G. In January 2022, in advance of the termination of the first one-year extension, The Tenant expressed to the Authority the desire to exercise the second of three one-year extensions
- H. On March 1, 2022, the Authority Board resolved to exercise a one-year extension for the period of November 1, 2022 October 31, 2023
- I. On March 16, 2022, County Council resolved to exercise a one-year extension for the period of November 1, 2022 October 31, 2023
- J. On May 2, 2023, the Authority Board resolved to exercise a one-year extension for the period of November 1, 2023 October 31, 2024
- K. On May 17, 2023, County Council resolved to exercise a one-year extension for the period of November 1, 2023 October 31, 2024

NOW THEREFORE the parties hereto agree as follows:

That the third of three one-year extensions be exercised for the period November 1, 2023 – October 31, 2024 under the same terms and conditions of the Lease Agreement.
