12.3. Shoreline Natural Hazard Mapping Initiative

Report number 2023-1115-IPS-R41-RB, Shoreline Natural Hazard Mapping Initiative, from Rebecca Belanger, Manager Planning Services, dated November 15, 2023.

Rebecca Belanger was joined by Tim Byrne, General Manager, Essex Region Conservation Authority to provide an update to the Shoreline Natural Hazard Mapping and Data Sharing Initiative Project. The project outlines flood prone areas along Essex County's 200-plus kilometres of shoreline and would be referenced to ensure development is planned in a responsible and safe manner.

Rebecca explained that the information obtained through the project would also be used to support the County's Emergency

Management Department in preparation of the Hazard Identification and Risk Assessment (HIRA) and the Infrastructure and Planning Department to assist in identifying vulnerabilities in the County's infrastructure.

Rebecca explained the portions of the project completed to date and details of the funding agreement with the Ministry of Natural Resources and Forestry.

Rebecca explained that next steps included hosting public information sessions to allow residents the opportunity to review specific sections of properties.

Jerry Behl and Diana Radulescu provided Council with the report regarding County Wide Active Transportation System (CWATS) Master Plan update.

Jerry reviewed the history of the CWATS charter and explained the update was to capture new best practices, implement Ontario Traffic Manual recommendations regarding cycling facilities and recognize the increased use of pedestrian infrastructure since the Charter's inception. The updates would allow for varying levels of ability and a broader variety of modes of transportation.

Jerry highlighted the programs included under the CWATS program and the plans for each going forward.

Discussion included the opportunities and challenges the current cost sharing arrangement between the County and the Local Municipal Partners provided.

Report number 2023-1115-IPS-R40-AB, Award of Contract for Engineering Services for the County Road 46 Schedule C Municipal Class Environmental Assessment from Allan Botham, Director, Infrastructure Services and Planning, dated November 15, 2023

Jerry Behl provided the tender summary for the project to hire a consultant to conduct an Environmental Assessment on County Road 46 from Windsor to County Road 19 (Manning Road).

Jerry noted that for efficiency, Concession Roads 8 and 9 would be included in the assessment. The Town of Tecumseh had approved the full reimbursement to County for their portion of the work.

12.6. County Road Rationalization Update

Report number 2023-1115-IPS-R42-AB, Update regarding County Road Rationalization, from Allan Botham, Director Infrastructure and Planning Services, dated November 15, 2023

Allan Botham provided Council a report on the history of the project since 2005.

Allan noted that in 2021, the regional CAO's agreed that it was appropriate to first update the County's Official Plan and then the County's Transportation Master Plan. Following the update of those plans, the Road Rationalization Study Terms of Reference and a formal Project Charter would be developed to support the study.

Per these recommendations, the draft Official Plan was scheduled to be presented to Council in early 2024 and the Transportation Master Plan was scheduled for completion in early 2025.

Allan provided an overview of the basic principles of the Road Rationalization Study Terms of Reference and Project Charter and emphasized the importance of including engineers, finance and planning representatives from the County and all Local Municipal Partners in this project.

Discussion included potential outcomes of the study, including the possibility of upload or download of County Roads to the Local Municipal Partners.

Councillor Crystal Meloche brought forward the following notice of motion at the November 15, 2023 meeting:

Whereas Administration will be presenting a revised Essex County Procedure By-law for County Council's consideration at the November 15, County Council Meeting;

And whereas County Council does not yet know the extent of the revisions that will be proposed in the revised By-law;

And Whereas Section 10.1 of the existing By-law provides that the Agenda and supporting documents will be made available "to members of Council in the calendar week prior to that in which the meeting falls" and such agenda is usually distributed on the Friday of that week;

And Whereas Section 10.3 provides that agendas and supporting material will be "posted on the County's website on the Monday preceding the meeting" unless the Monday is a holiday, at which point the material is published on the Tuesday;

And Whereas these publishing dates do not provide enough time for members of County Council, nor members of the public, to review the agenda material;

Accordingly, it is moved that, Section 10.1 of the Procedure By-law be amended to provide that the agenda, including supporting documents, be made available to members of council at least seven (7) days prior to the meeting;

And that Section 10.3 be amended to provide that the agenda, with supporting documents, be posted on the County of Essex's website at least seven (7) days prior to the meeting.

Mary Birch pointed out there was a date error in the first paragraph, it should read December 6, 2023.

Mary asked for clarification regarding the use of addenda to the agenda. Council was agreeable to an addendum agenda being posted up to the Monday before the meeting date if information became available between the earlier posting date and the meeting date.

Mary further suggested that there be at least one day between the day Council receives the agenda and it being posted to the website to allow Council some time to familiarize themselves with the reports should questions from the public arise.

Council was agreeable to implementing the revised schedule for agenda distribution to begin in January 2024.
