## 9. Unfinished Business

## 9.1 ErieShores Health Care Visit

The ECAAC was invited to attend an onsite tour of ErieShores Health Care (ESHC), Leamington, Ontario on March 25, 2024.

Dennis Sanson and Debbie Alexander attended the tour along with Katherine Hebert and Crystal Sylvestre form Administration.

Other attendees included the ESHC Accessibility Advisory Committee; Peter Best, City of Windsor AAC; and ESHC Facilities Staff.

Discussion included that some features in the building are original to the 70-year-old healthcare facility, therefore limiting some of the options to fully renovate the spaces. The facilities team was committed to making improvements or alterations wherever possible.

The tour included a walkthrough of the new MRI suite that was nearly complete and included many accessible features such as a large examination and procedure room, an accessible washroom, and automatic entrances. Plans were being made to harmonize and update signage throughout the building including textured surfaces to indicate transitions, blade signs, high contrast signage, wayfinding devices and colour coded areas.

As originally built, the facility has different grade entrances that enter and exit the building on different floors. The team was working on a solution to best communicate the locations of entrances and exits.

The current Cafeteria was unstaffed for periods of the day. During these periods, the area was self serve with a touch screen to facilitate purchases. Peter indicated that touch screens can be a barrier to people who are blind or have low vision. Some suggestions included implementing a screen that has voice prompts or offering a device to allow people to ask for assistance.
