**Reduce Financial Burden-** substantial and unnecessary financial burden to all taxpayers to acquire the land to widen County Road 22 as proposed with cycle tracks, sidewalks, multi-use walkway and boulevards. Additionally, incremental expenses for moving services, connections, and replacing landscaping of the property owners whose land will be required to be purchased, or expropriated.

**Recommendation**: Reduce scope of the proposal. Reduce width of sidewalk, eliminate cycle track (since there is a multi-use track) eliminate boulevards, benches and trees. These changes will reduce the cost of the project and the burden on the taxpayer. It will mitigate some of the safety concerns (though not eliminate them entirely). Benches are not necessary as people will not sit on a busy street to smell fumes and watch traffic.
