### 1.0 PURPOSE

To establish a policy that brings consistency to the manner in which requests for financial support of conferences/conventions to be held locally are responded to.

### 2.0 <u>SCOPE</u>

- .1 Applies to all requests for funds in whatever manner (i.e. program ads, sponsorships, function hosting, donations, etc.) from all sources.
- .2 *"Locally"* shall be intended to mean within the geographic boundaries of Essex County or of the City of Windsor.
- .3 *"Associations"* shall be intended to mean an umbrella organization of a provincial or federal nature.

### 3.0 **RESPONSIBILITY**

- .1 It is the responsibility of anyone contacted on behalf of the Corporation; elected officials, appointed officials or staff, to refer any and all requests to the Chief Administrative Officer for disposition.
- .2 All requests for funding shall be presented to County Council, through the Executive Committee, for approval.

### 4.0 <u>General</u>

- .1 A request for funding shall only be considered if all of the following criteria are met:
  - a) All requests shall be in writing and shall include a copy of the meeting agenda, the companion's agenda and an estimate of the number of delegates expected.

## 4.0 <u>General</u> (cont'd)

- .1
- b) Funding shall not be calculated on a *"per delegate"* basis but shall be fixed as to an amount.
- c) Functions or sponsorships for which funding is provided shall be "county" in nature (e.g. spousal program including tour of county, county entertainment, spotlight on county industry or area).
- .2 Levels of funding shall not exceed the following maximums:
  - a) Associations of which the county is a member; i.e. AMO County Section, F.C.M. -\$1,000.00.
  - b) Associations of which the county staff are members; i.e. AMCTO, MFOA, OMSSA, Non-profit Homes for Aged. etc. -\$500.00.
  - c) Associations of which local municipalities are members; i.e. AMO Small Urban Section, Conservation Authority. -\$1,000.00.
  - d) Associations of which local municipal staff are members; i.e. Building Officials, Fire Officials, Police Officials, Tax Collectors Assoc., etc. -\$500.00.
  - e) Associations of locally directly elected members or of County appointed members; i.e. School Boards, Suburban Road Assoc., Library Board, Waste Management Boards, etc. -\$1,000.00.
- .3 The source of funds to finance allocations made under this policy shall be the Promotional Events Reserve, the balance of which shall be considered annually during budget deliberations.

# 5.0 Exceptions

.1 County Council, shall have the authority to exceed the maximum contributions as set out above.
