#### **Purpose**

The purpose of this Administrative Report (the "**Report**") is to provide County Council with the necessary information for Council to recommend the appointment of a new Essex County Fire Co-ordinator and 2 alternate Fire Coordinators and to approve the remuneration for these officials.

## Background

As provided for in the *Fire Protection and Prevention Act, 1997*, S.O. 1997, c.4 (the "*Fire Protection and Prevention Act*") the Fire Marshal appointed by the Lieutenant Governor in Council, has the authority to appoint Fire Coordinators for a designated region. As provided for in Section 7 of the *Fire Protection and Prevention Act,* a Fire Coordinator "shall, subject to the instructions of the Field Marshal, (a) establish and maintain a mutual aid plan under which the fire departments that serve the designated area agree to assist each other in the event of an emergency; and (b) perform such other duties as may be assigned by the Fire Marshal."

Since 2011, the Chief of Windsor Fire & Rescue Services ("**Windsor Fire**") has been appointed as the Fire Co-ordinator for the Essex-Windsor Region, and a Deputy Chief of Windsor Fire and a Fire Chief of one of the fire departments of the lower-tier municipalities of the County have been appointed as the Alternate Fire Co-ordinators.

Windsor Fire Chief Stephen Laforet was appointed as the Regional Fire Coordinator on July 19, 2017 and Windsor Fire Deputy Chief James Waffle

and then Lakeshore Fire Chief Don Williamson were appointed as the Alternate Regional Fire Co-ordinators on September 4, 2019.

#### **Discussion**

Due to the retirement of former Windsor Fire Chief Stephen Laforet, the promotion of Windsor Fire Deputy Chief James Waffle to Chief of Windsor Fire, and Chief Don Williamson becoming Chief of the Leamington Fire Service, it is necessary for the Office of the Fire Marshal to make a formal appointment to fill the position of Fire Co-ordinator and the 2 positions of Alternate Fire Co-ordinator.

In January 2025, James Waffle was promoted to Chief of Windsor Fire thereby vacating his position of Deputy Chief of Windsor Fire. Daemon Hart has been hired to the position of Deputy Chief of Windsor Fire. Windsor Fire Chief Waffle has notified the County of his recommendation that Deputy Chief Hart be appointed to one of the positions of Alternate Fire Coordinator, effective as of March 1, 2025.

Chief Don Williamson, of the Leamington Fire Service, shall remain in place as the other Alternate Fire Co-ordinator, but with a fresh By-law accurately reflecting that he is no longer employed with the Lakeshore Fire Service, and is now with the Leamington Fire Service.

The Office of the Fire Marshall is now requesting a letter of support from County Council, prior to formalizing the appointments outlined above in this Report.

Remuneration for the Fire Co-ordinator and Alternate Fire Co-ordinators was established by an Agreement and authorized by By-law. That Agreement was last revised in 2019 and no change to the amount of remuneration is being proposed. The annual remuneration for the Fire Co-ordinator is the sum of \$5,000 and the annual remuneration for the Alternate Fire Co-ordinators is the sum of \$1,250 each.

# **Financial Implications**

There are no financial implications as the remuneration for the Fire Coordinator and the Alternate Fire Co-ordinators are within the 2025 approved Budget.
