Subject: Non-Smoking and Non-Vaping Policy

Purpose

The purpose of this Administrative Report (the "**Report**") is to provide County Council with the necessary background information to approve and adopt a new Non-Smoking and Non-Vaping Policy (the "**New Policy**"), a draft of which is appended to this Report as **Appendix A**.

Background

In 2003, County Council approved a Non-Smoking Policy as a Corporate Policy of the County, being Policy Number 03-002 (the "**Current Policy**"). A copy of the Current Policy is appended to this Report as **Appendix B**.

In the 22 years since the passing of the Current Policy, there have been a number of changes to legislation and other regulatory requirements that the Current Policy does not account for. Specifically, legislative changes have been implemented in the *Smoke-Free Ontario Act, 2017*, S.O. 2017, c. 26, Sched. 3 (the "**Smoke-Free Act**"), which have not been addressed in the Current Policy.

Both the *Municipal Act* and the *Smoke-Free Act* now account for the legalization of cannabis and the advent and increasing use of vaporizers and electronic cigarettes, which the Current Policy is silent on and does not account for. As such, the approval and adoption of the New Policy is being recommended.

Discussion

The *Smoke-Free Act* references a number of issues that no one had turned their minds to in 2003, including the introduction of vaporizers and electronic cigarettes and the legalization of cannabis. This has resulted in the Current Policy being outdated and not in line with the current Provincial requirements provided for in the *Smoke-Free Act* and the Regulations thereto.

The New Policy aligns with the *Smoke-Free Act*, now referencing items such as cannabis, vaporizers, and electronic cigarettes and references the existing Non-Smoking By-laws of the County. There is a provision that recognizes that there may be conflicting provisions in the New Policy, the *Smoke-Free Act*, and the County's Non-Smoking By-laws, with the conflict being resolved in favour of the most restrictive interpretation.
