Resident Focused Care



- Requiring acute interventions
 - Oxygen therapy
 - Monitoring acute conditions
 - Administering IV medications
 - Monitoring input/output
 - 1 in 3 residents completely dependent for toileting and feeding
- Multiple problems, including mental health
 - Compared to the rest of the province, the Erie St. Clair population has higher rates of occurrence for arthritis, asthma, diabetes, hypertension, mood disorder, chronic obstructive pulmonary disease (COPD), and heart disease (Source: Integrated Health Services (IHSP) Plan 3 (2013-2016))
- Responsive behaviours
 - some residents require 1:1 staffing
 - can be up to 3 residents at any one time
- 39% have mental health issues
