A BY-LAW TO AUTHORIZE THE EXECUTION OF AN AGREEMENT WITH HER  
MAJESTY THE QUEEN IN RIGHT OF THE PROVINCE OF ONTARIO AS  
REPRESENTED BY THE MINISTER OF TRANSPORTATION FOR THE PROVINCE  
OF ONTARIO – ONTARIO MUNICIPAL COMMUTER CYCLING PROGRAM - **<Year>-**

WHEREAS it is deemed expedient to authorize the execution of an Agreement  
with Her Majesty the Queen in right of the Province of Ontario as represented by the  
Minister of Transportation for the Province of Ontario for funding under the dedicated  
Ontario Municipal Commuter Cycling Program (OMCC).

NOW THEREFORE THE COUNCIL OF THE **<MUNICIPALITY>** HEREBY  
ENACTS AS FOLLOWS:

1. THAT the Mayor, Clerk and/or Treasurer are hereby authorized to execute on  
behalf of the **<MUNICIPALITY>** an Transfer Payment Agreement (Agreement)  
with Her Majesty the Queen in right of the Province of Ontario as represented by  
the Minister of Transportation for the Province of Ontario for **<Year>-** funding  
under the OMCC.
2. THAT **insert titles(s)** have the delegation of authority to execute any and all  
required documentation on behalf of the **<MUNICIPALITY>** as required by the  
OMCC for 20**17**xx.

3. THAT the <MUNICIPALITY> commits to providing funding equivalent in <Year>-  
to twenty percent of <Year>-funding provided to the <MUNICIPALITY> under the  
OMCC.
4. THAT the <MUNICIPALITY> commits to implementing projects and spending  
OMCC <Year>- funding in accordance with all provisions specified in the  
Agreement.
5. THAT the <MUNICIPALITY> commits to spending OMCC <Year>- funding only  
on the following approved projects:
  - a. [Project name
  - b. Project name
  - c. Project name
6. THAT the <MUNICIPALITY> commits that it will obtain all required approvals  
have been obtained for each project prior to use of OMCC funding.
