## **Purpose**

The purpose of this report is to provide County Council information and recommendations pertaining to tender results for a series of road rehabilitations to be undertaken as part of the 2018 Rehabilitation Program.

## **Background**

Upon approval of the 2018 Rehabilitation Program, tenders for asphalt pavement resurfacing were issued. This tender includes resurfacing of recycled road segments and straight asphalt overlays. The following is a listing of the road projects, and locations are shown on the attached maps.
