

The Corporation of the County of Essex By-Law Number 09-2018

A By-law to Authorize the Execution of an Agreement with Her Majesty The Queen in Right of the Province of Ontario as represented by the Minister of Transportation for the Province of Ontario – Ontario Municipal Commuter Cycling Program - 2018.

Whereas it is deemed expedient to authorize the execution of an Agreement with Her Majesty the Queen in Right of the Province of Ontario as represented by the Minister of Transportation for the Province of Ontario for funding under the dedicated Ontario Municipal Commuter Cycling Program (OMCC).

Now therefore the Council of the Corporation of the County of Essex hereby enacts as follows:

- 1) THAT the Warden and Clerk are hereby authorized to execute on behalf of the Corporation of the County of Essex a Transfer Payment Agreement (Agreement) with Her Majesty the Queen in Right of the Province of Ontario, as represented by the Minister of Transportation for the Province of Ontario for 2018 funding under the OMCC.
- 2) THAT authority be delegated to the Chief Administrative Officer (CAO) to execute any and all required documentation on behalf of the Corporation of the County of Essex as required by the OMCC for 2018.
- 3) THAT the Council of the County of Essex commits to providing funding equivalent in 2018 to twenty percent (20%) of 2018 funding provided to the Corporation of the County of Essex under the OMCC.
- 4) THAT the Council of the County of Essex commits to implementing projects and spending OMCC 2018 funding in accordance with all provisions specified in the Agreement.

- 5) THAT the Council of the County of Essex commits to spending OMCC 2018 funding only on the following approved projects:
 - CWATS Master Plan Update
 - Intersection Improvements CR 20
 - Bike Lockers
 - Ess-6 CR 50 paved shoulders
 - Kings -1 -CR 34 Paved Shoulders
 - Kings-2 CR 34 paved shoulders
 - Kings-5 CR 34 paved shoulders
 - Kings-18 CR 29 paved shoulders
 - Kings-8 CR 50 paved shoulders
 - Kings-13A CR 20 paved shoulders
 - Kings-13B-CR 20 multiuse path
 - Lake 11 -CR 2 multiuse path
 - Leam-11A-CR 20 multiuse path
 - Leam-11B -CR20 multiuse path
 - Leam-11C-CR20 multiuse path
 - Leam-17 CR 33 paved shoulders
- 6) THAT the Council of the County of Essex commits that all required approvals will be obtained for each project prior to use of OMCC funding.
