Purpose

The purpose of this report is to provide County Council information and recommendations pertaining to tender results for a series of road rehabilitations to be undertaken as part of the 2018 Rehabilitation Program.

Background

Upon approval of the 2018 Rehabilitation Program, tenders for asphalt pavement resurfacing were issued. This tender includes the milling and paving of road segments including the intersection of County Road 20 and Morton Drive. The costs associated with the rehabilitation of this intersection will be shared with the City of Windsor and the Town of LaSalle.
