#### **Purpose**

The purpose of this report is to provide County Council information and recommendations pertaining to e-tender results for a bridge rehabilitation project to be undertaken as part of the 2018 Rehabilitation Program.

#### **Background**

The approved 2018 Rehabilitation Program includes the rehabilitation of the County Road 42 Bridge over Tremblay Creek.

The scope of work on this project includes the upgrade of the guide rail system, replacement of the parapet and railing system, repairs to the underside of the concrete bridge deck and abutments as well as pavement preservation. The proposed works will not require a road closure as temporary traffic control signals will be utilized to maintain a single lane of traffic over the bridge for the project's twelve week duration.

The location of this project is shown on the attached map. (Appendix 1)

## **Discussion**

The bridge projects included in the 2018 Rehabilitation Program involve complex work requiring specialized operations for repair and rehabilitation of the bridge super structures over navigable waterways with some located within provincially significant Wetlands. Recognizing the complex and sensitive nature of the work a prequalification process for contractors was utilized.

Sixteen firms met the prequalification requirements and were subsequently invited to submit e-tenders for the projects. The contracts provide liquidated damages intended to provide schedule compliance.

Tender results were aligned with the Engineer's Estimate and within the project budget.

The following is a summary of the tenders received.
