#### **Purpose**

The purpose of this report is to provide County Council information and recommendations pertaining to tender results for a culvert rehabilitation project to be undertaken as part of the 2018 Rehabilitation Program.

## Background

The 2018 Structure Rehabilitation program includes the complete replacement of the concrete box culvert on County Road 34 at the Wilkinson-Shilson Drain located in the Municipality of Leamington.

The works are intended to occur during the fall of 2018.

#### **Discussion**

The tender process utilized electronic bidding. The electronic submissions were evaluated for compliance with specifications and mathematical accuracy. The submissions were complete with no discrepancies identified.

Southshore Contracting Inc.	\$649,265.00
Shearock Construction Group Inc.	\$698,876.00
SLR Contracting Group Inc.	\$710,750.00
Murray Mills Excavating and Trucking (Sarnia) Ltd.	\$786,530.80

Despite the variances between the Engineer's estimates and the tender results for this project, Administration continues to anticipate that no changes to the overall 2018 Rehabilitation Program are required. The overall program budget can accommodate the higher than anticipated tender results. Administration will continue to monitor tender results and will respond as circumstances warrant.
