Purpose

The purpose of this report is to provide County Council information and recommendations pertaining to the tender results for the construction of active transportation pathway along County Roads to be undertaken as part of the 2018 CWATS Program.

Background

Included in the approved 2018 CWATS Program, a project along County Road 2, in the Town of Lakeshore, was approved by the CWATS Committee with the Town agreeing to fund their share of the project costs. This project will provide 1.5 km of active transportation facilities consisting of paved shoulders on both sides of the road and a multi-use path on one side of the road from VIA Rail to Wallace Line. A tender for the construction of the active transportation pathway along County Road 2 was issued for the location as shown on the attached map.

Discussion

The following is a summary of the tenders received. All amounts do not include HST.

Financial Implications

The tender results are within the Engineer's estimate. The project includes a small allocation for pavement rehabilitation that is full County responsibility. The majority of the project costs are shared between the County and the Town of Lakeshore. The cost allocation follows the standard established CWATS cost share formula of 60% to Lakeshore and 40% to the County. The Town of Lakeshore was provided an opportunity to review the tender results and has provided their concurrence in awarding the contract.

Recommendation

The tenders were reviewed for compliance with the specifications and mathematical accuracy.

It is recommended that the tender for the active transportation pathway on County Road 2 be awarded as follows:
