#### Discussion

The 2017 Annual Report of the Windsor/Essex Provincial Offences Program and 2017 Audited Financial Statements were presented to and approved by the members of the Windsor/Essex Court Service Area Liaison Committee on March 21, 2018. Members were requested to provide the 2017 Annual Report and Financial Statements to their respective Councils. Copies are attached as Appendix A and B, respectively.

# Financial Implications

The Report indicates that charging volumes decreased in 2017, by 5.1% from the prior year. With a few exceptions, declining charging volumes appear to be a trend across the Province.

Efforts were focused on collections of defaulted fines in 2017. Collection methods such as adding outstanding fines to tax rolls, wage garnishments, plate denials and 3<sup>rd</sup> party collection agencies were all utilized to increase the collection of defaulted fines. Despite the collection efforts for the year 2017, the net operating income of \$1,312,109 is down 34.2% from 2016. There was a negative variance of \$411,567 (23.9%) from the \$1,723,676 budgeted revenue.

#### Recommendation

That Essex County Council receive the 2017 Annual Report and 2017 audited Financial Statements pertaining to the Windsor/Essex Provincial Offences Program.
