Purpose

The purpose of this report is to provide County Council information and recommendations pertaining to the tender results for the construction of an active transportation facility along County Roads to be undertaken as part of the 2018 CWATS Program.

Background

Included in the approved 2018 CWATS Program is a project along County Road 20, in the Municipality of Leamington. The project was approved by the CWATS Committee with the Town agreeing to fund their share of the project costs. This project will provide 3.2 km of active transportation facilities consisting of pathways on both sides of the road. A tender for the construction of the active transportation pathway along County Road 20 was issued for the location as shown on the attached map.

Discussion

The following is a summary of the tenders received. All amounts do not include HST.

Financial Implications

The project includes an allocation for guide rail upgrade that is full County responsibility, and also includes a small allocation for sidewalk construction that is full Municipality responsibility. The majority of the remaining project costs are shared between the County and the Municipality of Leamington. The cost allocation follows the standard established CWATS cost share formula of 60% to Leamington and 40% to the County. The Municipality of Leamington was provided an opportunity to review the tender results and has provided their concurrence in awarding the contract.

Recommendation

The tenders were reviewed for compliance with the specifications and mathematical accuracy.

It is recommended that the tender for the active transportation pathway on County Road 20 be awarded as follows:

CWATS Active Transportation Pathway on County Road 20 to Pierascenzi Construction Ltd. for a total tender amount of \$2,678,075.00 plus H.S.T.
